When Arizona Chemicals Company, LLC was acquired by Kraton Polymers in the beginning of 2016, Mr. Verhaar became a shareholder of Ten Cate, which had been taken private by private equity group Gilde (Gilde Buy Out Partners). He currently serves as chairman of the Advisory Boards of three of the five group companies that comprise Ten Cate, being Advanced Composites, Protective Fabrics, and Advanced Armour.
